Started the year 2020, with Volume 15, news: modernized graphic project, with new cover and core format, diagramming of the pages for easier reading of texts, English version of articles written in Portuguese and the MP3 audio version, novelty and novelty among journals edited in Brazil, adhering extensive program of social inclusion in the *Stricto Sensu* Graduate Program in Law (PPGD) of FUMEC University.
